2. Highlights for the quarter

- All schools have signed Memorandum of Understanding (MOUs) for 2020.
- We managed to finalise all the activities for the first quarter as per our year plan
- DEP sessions have commenced, and the learners are excited about their continuous learning journey
- The SP Team were trained in-house, on Facebook Live as well as Google Classroom.
- Given the unprecedented nature of the Covid-19 Pandemic, staff have been very pro-active to learning about new ways of communicating with young people, and their flexibility and enthusiasm to find ways to continue supporting young people on their education during and after the lockdown period - especially using digital, online approaches, has been commendable.

3. List challenges encountered this quarter

• The Covid-19 Pandemic hit - and this was the main challenge that we encountered this quarter, as schools closed earlier than normal.

 Even though our staff spent time in the office for strategic planning and to commence preparations for a possible lockdown - it is not possible to prepare for such an unprecedented situation.

4. Recommendations or plans for the next quarter

- Our Rapid Response Plan is to communicate with learners and educators using a variety of online and digital platforms (WhatsApp, Facebook Live, Google classroom etc). While the learners are still <u>out of school</u> due to the lockdown period, OVSA will commence with delivering workshops via Facebook Live and Google Classroom and learners can interact with the Facilitators via these platforms.
- OVSA will also provide learners with Covid-19 support; either through regular updates delivered prior to workshop delivery, or via a Q&A site on the Facilitator's facebook page.
- We are currently also exploring a Youth Hotline that focusses on providing 3-in-1 information to young people on the Corona virus, TB and HIV. This Hotline also presents a secondary safety net for learners who may be depressed and/or suffer anxiety.
 - It may be worth looking at the possibilities of supporting schools on their catch-up plans and revision exercise, once grades are phased back in.
